#### 1. Why are you seeking this position?

I have a deep love for politics, especially from the policy-making and relational perspective. This position brings together all the things I love most - advocating for private property rights and protecting our ability to conduct business, serving our clients and our communities and protecting their right to buy and sell real estate, and building relationships with elected officials to help keep the American dream of homeownership alive. The position of Vice President of Government Affairs is a conduit between our members and our Government Affairs & lobbying team and I am excited for the opportunity to fill that role.

#### 2. What is your understanding of the responsibilities of the Vice Presidentelect of your Committee?

The responsibilities of Vice-President elect are to support the Vice President in all of their responsibilities, fill in for them in their absence, attend all Executive Committee and Board of Director meetings (also serving as a Director), have a working knowledge of Washington REALTORS®' governing documents.

### 3. What skills and abilities do you have that will help you to be an effective volunteer leader of WR?

I'm an effective public speaker and connect well with my audience. I strive to understand what matters to my audience prior to speaking. I am an effective listener and listen to understand and hear where others are coming from. In an environment where we all have different opinions about the direction of our advocacy and our association, this is a critical skill to possess. I am detail-oriented and thorough in working to understand things and people. In this position specifically, these skills are important with understanding what is written in bills we are watching, as well as with being able to find out what matters to our members and our legislators and helping to find where we can reach common ground.

### 5. What two major issues are facing your Committee and how do you propose to deal with those two issues?

First, private property rights and business issues are under constant attack. Every year, and more specifically every legislative session, this is a major issue we face. Although there are members who might disagree, we have been very effective in dealing with this. We have a brilliant GA team - our lobbyists are highly effective at building relationships, at advising us in the best possible way, at listening to our members' wants and positions, and staying proactive in pushing our position while also being prepared to play defense when it is needed. During elections, we work closely with our RPAC Trustees and our GA team to be the most effective we can with building relationships early during elections, and then continuing to build those relationships as legislators are elected/re-elected. Of course there's always room for refinement and improvement, but we have continued to elevate the caliber and skill of our GA team to

face this issue in the best way possible. Second, our second major issue we face is fundraising for RPAC. While this is the issue, beneath the surface is the greater issue of member apathy and/or lack of awareness. I've experienced this first hand as I've traveled across the state speaking at RPAC events. I don't believe it is because we have members who don't care; I believe it's from a lack of true understanding why our advocacy work matters so much. To address the issue, one of the most effective ways is to meet the members where they're at. There are two ways this works well: the first is to hold more education events that have nothing to do with fundraising. There are various ways to do this to create something fun and interesting, such that members want to participate. The second way is to implement more grassroots education. This best happens through one-on-one member discussion, often in casual settings. We must empower our members who understand and appreciate the urgency of our advocacy work to do this more often, and teach those members how to educate without doing it from a position of pressure or guilt.

We convey the importance by getting them to understand why our advocacy matters. We do that through the latter part of my answer to #5 above. Until a member is fully emotionally connected with and invested in why it matters, these won't be a priority.

Handling conflict really depends on the situation, the setting, and the conflict. If there is a conflict that could arise in a meeting, it's important to set the expectations at the

beginning of the meeting. Sometimes this means proactively talking with members prior to a meeting to help work through an issue that's arisen so it doesn't create an unproductive meeting. If conflict did arise, I would stop the conflict, then figure out how to properly handle it. If the conflict with the staff was something that needed addressing, I would report it to their supervisor or the CEO, as it is not within my role as a member to address certain issues with staff.
