Click the link in the message and enter your NRDS# and 4-digit code provided. This will provide access to the secure WR voting page:

- a. The page will populate motions when there is a “live” vote in progress.
- b. Once a motion is “live” on your screen, enter your vote and click “Verify Your Selection.”
- c. Confirm your choice and click “Submit Ballot.”
- d. Then click “Next Vote” which will take you to our landing page for the next vote to populate.
- e. **Reminder:** Do not close your voting screen. We will be voting throughout the meeting – so keep it open and available.
- f. Once the previous vote is verified, the following item for vote will appear on your screen.
